## MINUTES LANGHORNE MANOR BOROUGH COUNCIL MEETING OF MARCH 21, 2017

1. CALL TO ORDER - The meeting of Langhorne Manor Borough was called to order in the Langhorne Manor Borough Hall, 618 Hulmeville Avenue, Langhorne, Pennsylvania, on Tuesday, March 21, 2017 at 8;05 P.M. Eastern Time by William McTigue, President.

At this point in the meeting, Mayor Byrne led us in the "Pledge of Allegiance."

Mr. McTigue stated that the modular builders had not been able to talk with Vaughn Collaborative so there was no report on the new police facility.

Mr. John Moser a contractor who is interested in the new police facility was in attendance at the meeting this evening. Mr. McTigue explained what the plans are and that Council is considering a modular structure. Mr. Moser will be getting a CD of the original plans that Vaughn Collaborative had provided for \$175.00 deposit,

Mr. Pizzola reviewed the estimated for the proposed road project. Pickering Corts & Summerson bid was \$308745.00, estimated \$27.21 per Lineal Foot. Middletown Township estimate was \$184,000.00, cost of \$18.04 per Lineal Foot. That is a savings of \$124,745.00. The funds available are:

Highway Aid--\$91,000.00 2017 Highway Aid--\$35,000.00 Street Improvement--\$225,000.00 2017 Street Improvement--\$48,000.00 Total \$399,000.00

Mr. Pizzola is requesting permission to have Langhorne Manor Borough be put on Middletown Township's paving list.

Motion was made by Mr. Pizzola and seconded by Mr. Ferraro to ask Middletown Township to put in their bid to mill and pave 9700.00 Lineal Feet and to mill and pave instead of chip and seal Station Avenue and Hill Avenue. No objections were presented. Motion carried.

Mr. Ferraro explained what kind of a lock and panic buttons for the Administration Building he was looking into, Mr. Ferraro will have more information for the April 4, 2017 Council meeting.

**10. ADJOURNMENT** – Mr. McTigue entertained a motion to adjourn this meeting. Motion was made by Mr. Pizzola and seconded by Mr. Ferraro to adjourn this meeting. No objections were presented. Motion carried. Meeting adjourned at 8:45 P.M.
