ORDINANCE NO. 2006- OA

AN ORDINANCE OF THE BOROUGH OF LANGHORNE MANOR, BUCKS COUNTY, PENNSYLVANIA, FURTHER AMENDING CHAPTER 163, VEHICLES AND TRAFFIC, OF THE LANGHORNE MANOR BOROUGH CODE ADOPTED AS ORDINANCE NO. 95-06-01 ON JUNE 6, 1995 WHICH AMENDMENT PROVIDES FOR THE INCREASING OF FINES FOR VIOLATIONS OF THE PARKING REGULATIONS CONTAINED IN THE ORDINANCE.

BE IT ENACTED AND ORDAINED by the Council of the Borough of Langhorne Manor, County of Bucks and Commonwealth of Pennsylvania, and same is ENACTED AND ORDAINED as an Ordinance of the Borough as follows:

Chapter 163 Vehicles and Traffic adopted as Ordinance No. 95-06-01 on June 6, 1995, and amended by Ordinance No. 95-08-01 on August 1, 1995 and by Ordinance No. 2003-001 on November 5, 2003, and by Ordinance No. 2005-005 on September 6, 2005, and by Ordinance No. 2005-006 on October 4, 2005 is hereby further amended to and shall henceforth provide that fines for violation of the parking regulations contained in the Ordinance shall henceforth be as follows:

1. Parking Violations Fines.

- a. Article I. General Provisions.
 §163-3. Temporary and Emergency Regulations. Subparagraph B.
 One Hundred (\$100.00) Dollars.
- b. Article IV. Snow and Ice Removal.
 §163-32. Penalty for Violations. Subparagraph A.
 Twenty-Five (\$25.00) Dollars.
- c. Article IV. Snow and Ice Removal.
 §163-32. Penalty for Violations. Subparagraph B.
 One Hundred (\$100.00) Dollars.
- d. Article VI. Interpretation and Repeal.
 §163-46. Violations and Penalties. Subparagraph A. Twenty-Five (\$25.00) Dollars.
- e. Article VI. Interpretation and Repeal. §163-46. Violations and Penalties. Subparagraph B. Twenty-Five (\$25.00) Dollars.

2. Declaration of Purpose.

It is declared that the enactment of this Ordinance is necessary for the protection, benefit and preservation of the health, safety and welfare of the inhabitants of the Borough.

3. Repealer.

All Ordinances or parts of Ordinances inconsistent with this Ordinance shall be, and the same are hereby repealed.

4. Effective Date.

This Ordinance shall be effective immediately upon adoption.
